#### - Charlotte Waite, Director of Transformation and Systems Change 'Lessons from the pandemic'

The presentation will explore the findings from a series of conversations Platfform held with publics service and community practitioners across Wales during the pandemic. Many of the Lessons from Lockdown (Lessons-from-Lockdown-report.pdf

(platfform.org)) are by now familiar: collaboration, focus on what matters and localism flourished but others exposed holes in organisational cultures at odds with trauma informed, healing focussed and asset based ways of working.

#### - Ann Hamlet, Head of Safeguarding, Aneurin Bevan University Health Board 'Lessons from Adult Practice Reviews'

When a child or adult dies or suffers serious or permanent impairment of health and abuse or neglect is suspected a review of the case is undertaken. The purpose of a review is to examine how well agencies work together to protect the individual. We use an approach that looks at systems and identifies learning for agencies. presentation will look at the learning undertaken from a recent Adult Practice Review, which included the themes of coercive control and mental capacity.

#### - Jon Drake, Violence Prevention Unit Director, South Wales Police 'Violence Prevention in Wales'

The presentation will cover the impact of violence in Wales with a particular focus on children and young people. During this I will discuss the work of the Violence Prevention Unit, and the

partnership approach being used to help prevent harm. Research conducted by the VPU on what works to prevent violence in different forms will also be covered and shared.

- Donna Sharland, Autside Director, 'Autism and Radicalisation' Donna Sharland is an autism specialist currently managing an autism pilot for WECTU. The pilot is to support autistic candidates in the prevent program and provide specialist advice and guidance to aid the channel process. The Prevent strategy, launched in 2007 seeks to stop people becoming terrorists or supporting terrorism both in the UK and overseas.

# - Emma Coopey, Detective Inspector, Gwent Police, 'Operation Pinebank'

The presentation will include an insight into Operation Pinebank which is an investigation into County lines which affected children and young people in Cwmbran. The presentation will show how quick it took for a London drug gang to embed themselves within our community and the devastating affect it had on the their victims and families. Reviewing some of the lessons learnt and discussing what worked well, the presentation aims at supporting partners to become more resilient and confident in dealing with this complex crime.
